1. ELECTION OF CHAIRMAN – Church Yard and Cemetery Sub-Committee

It was proposed by Cllr Shevde and seconded by Cllr Wiles that Cllr Pemble should be elected as Chairman of this committee, there being no other nominations this was put to the vote, all agreed.

Cllr Pemble asked that a vice chairman also be elected for this committee, it was proposed by Cllr Pemble and seconded by Cllr Hooper that Cllr Kemp be elected as vice chairman, there being no other nominations this was put to the vote, all agreed.
